## AMI Leading the Way

- In under 5 days, AMI provided all clinical staffing and governance for a 200-bed COVID-19 field hospital within the Georgia World Congress Center in Atlanta, GA. Patient acuities ranged from ICU step down to monitored bed care through routine COVID ward care.
- AMI was awarded Prime Contractor by the United Nations office in Somalia to operate and manage the UN Level 1+ medical facility located on Mogadishu International Airport (MIA). AMI provided critical surge capacity including the establishment of an ICU to UNSOS in response to COVID-19.
- AMI provided clinical staffing and project management support while caring for a 100-bed COVID-19 high acuity ward. AMI cared for upwards of 400+ patients for Mount Sinai Beth Israel Hospital System in New York City. The entire clinical solution was delivered in under 7 days.
- AMI continues to support The Kingdom of the Netherland's islands of St Maarten, Aruba, and Curacao with augmented ICU care for COVID-19 patients, AMI is providing clinical governance, staff, medical equipment, pharmaceutical and consumable supplies. Services also include staffing critical care physicians, ICU RNs, Respiratory Therapists, and other support staff.
- We have successfully performed over 10,000 tests in the first 30 days of our Pennsylvania contact. Our two testing teams consist of 24 medical professionals and they have visited six counties. We operate twelve hours a day seven days a week to provide safe, accurate, and timely testing for the local populations.
- One of our most notable accomplishments has been the refinement of a Medical Task Force combating COVID-19 in Assisted Living Facilities. In California's San Mateo County, AMI's Medical Task Force had two distinct components – the Initial Assessment Team and the Stabilization and Treatment Team. Over 10,000 tests have been completed in the Bay Area at over 500 facilities.

- Management of multiple 100 - 200 bed ward sites with acuity levels ranging from ICU to lower level care
